MINUTES OF MEETING OF BOARD OF DIRECTORS May 24, 2021

MONTGOMERY COUNTY UTILITY DISTRICT NO. 3

The Board of Directors ("Board") of Montgomery County Utility District No. 3 ("District") met in **special** session, open to the public, on **May 24, 2021** at **1:00 PM**, at the offices of Hays Utility North Corporation (the District's utility operator) at 375 Lake Meadows Drive, Montgomery, Texas 77356, in Montgomery County, Texas and via a telephone conference call audible at that location (with two way audio), as authorized by the Governor of Texas under an emergency declaration, whereupon the roll was called of the members of the Board, to-wit:

Doris Hickman, President Richard Tibbetts, Vice President Janis Boulware, Secretary and Assistant Treasurer Carolyn H. Smith, Treasurer Judy Robert, Assistant Secretary

and all members of the Board were present at the meeting place. Also present at the meeting location were James Dougherty, special counsel for the District and Travis Walker and John Bleyl of Bleyl Engineering. There was nobody present via telephone conference call. Later in the meeting, Mr. Walker and Mr. Bleyl departed, and Mr. Chris Roznovsky and Katherine Vu of WGA Consulting Engineers (Ward, Getz & Associates, PLLC) arrived. The meeting was called to order by the President, and in accordance with notice attached as *Exhibit A*, the following business was transacted:

- 1. Notices, Minutes, Etc. The Secretary reported that the notice of the meeting had been posted as required by law, in the form shown in *Exhibit A*, attached. It was moved and seconded to approve and adopt the notice. Action on draft minutes was deferred.
- 2. Engineering. Mr. Bleyl and Mr. Walker presented slides showing a water modeling project that Bleyl Engineering had done, also an example of a GIS system the firm had developed. The mentioned types of projects they had worked on and gave a list of clients with contact persons. references. Mr. Walker explained that their firm would to actual data input, also that the firm could either host the GIS systems on its computers or work with the system if hosted by a third party. There were questions and a general discussion of the water modeling project, also related issues (transmission, production, water quality, etc.). Mr. Bleyl and Mr. Walker said they had reviewed the draft engineering services agreement, and their firm was able to provide the scope of services and could otherwise perform under the agreement. There were questions about NACE inspections, also about the District working with different engineering firms. Mr. Bleyl mentioned that he proposed to serve as the principal engineer for the District (with three others in support), and Mr. Walker would be the "project manager." He said the manager of the public works group would not be directly involved. Mr. Bleyl explained that he does his own engineering reports and water rate work. There was further discussion.

Mr. Bleyl and Mr. Walker left the meeting around 2:15 PM. Shortly thereafter, Mr. Roznovsky and Ms. Vu arrived

Mr. Roznovsky described the background of WGA and some of its key personnel. He reviewed the utility systems and development of other clients, also work done in the past for the District. Ms. Vu gave a demonstration of two different GIS systems, and there was a discussion. Mr. Tibbetts asked about coordination among multiple engineering companies serving one district. Mr. Roznovsky explained proposed engineering arrangements of the City of Montgomery. Mr. Roznovsky and MS. Vu

said they had reviewed the draft for an engineering services agreement, and WGA could provide the scope of services and otherwise perform under the agreement. There were questions and discussions about the water and sewer facilities serving the April Sound area, including water plants, water lines (existing and proposed) and sewer lines. There was a question about water quality, including blending.

7. Operations. The President gave an update on the manhole failure and the related lines and manholes, also the cost of running the bypass. After discussion, Director Smith moved to authorize the President to make and execute contracts as necessary to make emergency repairs and related rehabilitation as indicated by televising, because of the need to take action immediately. Director Tibbetts seconded, and all voted in favor.

A motion was made to adjourn the meeting at about 4:00 PM. The motion was seconded and carried unanimously.
